# Tatarstan is economy

The Republic of Tatarstan is one of the most economically developed regions of the Russian Federation making the significant contribution to country's economy.

The Republic of Tatarstan possesses rich natural resources, the powerful and diversified industry, high intellectual potential and the qualified labor. The Republic of Tatarstan, using 2.2% of the farmland of Russia, makes about 4.4% of agricultural products of the country. The industrial profile of the republic is defined by a petrochemical complex (oil production, production of synthetic rubber, tires, polyethylene and a wide range of products of oil refining), the large machine-building enterprises making competitive production (heavy trucks, helicopters, planes and aircraft engines, compressors and the oil and gas pumping over equipment, river and sea vessels, scale commercial and cars), and also advanced electro - and radio instruments.



# The Federal special economic zone "Alabuga"

alabuga.ru

SEZ «Alabuga» was created in 2006 and provides investors with completely prepared industrial, engineering, transportation and customs in frastructures, as well as a number of tax and customs privileges. Among the resident companies there are corporations of world business as Ford-Sollers, Saint-Gobain, Air Liquide, Rockwool, Sisecam, Hayat Group, 3M, Coşkunöz, Kastamonu, HAVI Logistics, Armstrong, Dizayn Group.etc.

The residents of SEZ "Alabuga" are provided with the following tax privileges:

- the lowered tax rate on profit of 13.5% instead of standard 20%;
- transport tax exemption within ten years from the date of registration of the vehicle;
- property tax exemption within ten years from the date of registration of property in the accounting report;
- land tax within exemption ten years for the land lots located in the territory of SEZ;
- higher depreciation rate can be applied to the taxation (namely, the standard norm of depreciation charges shouldn't exceed the norm twice).

More than 605.7 mln USD have been invested in development of the infrastructure of the Special economic zone "Alabuga" by the federal and regional authorities.



# The Federal special economic zone "Innopolis"

Started at 2012 Innopolis is a new IT Smart City which uniting young highly qualified specialists from all over the country, strengthening thereby the innovative capacity of the Russian Federation.

Innopolis is a smart city with branched business infrastructure (science and technology parks, the centers of development, etc.), a full range of social and commercial infrastructure (schools, kindergartens, hospitals, shopping centers, restaurants, etc.) and housing of various level (from apartment houses to townhouses and cottages) they mostly will be provided for rent to the staff of the resident companies with the right of the subsequent repayment.

Residents of the SEZ "Innopolis" are provided with the following tax privileges:

- of income tax exemption payment within five years from the moment of receiving the first profit. The next five years the tax rate for them will make 5%, after 10 years 13.5%;
- transport tax exemption;
- the property tax is 0% (within 10 years), the land tax will also makes 0% within the first 5 years;
- insurance premiums for residents of the SEZ "Innopolis" make only 14% according to the current legislation of the Russian Federation till 2017.



# The Territory Of Advanced Development "Naberezhnye Chelny"

The territory of advanced social and economic development "Naberezhnye Chelny" was established in 2016.

Territory of Advanced Development (TASED) is a part of the territory of the Russian Federation, including the closed administrative and territorial entity, which in accordance with the decision of the Government of the Russian Federation offers a special legal regime and tax preferences for entrepreneurs providing favourable conditions for investment.

TAD was created for 10 years, with the possibility to extend its activities for another 5 years.

Requirements for investment projects of residents at the Ter-ritory of Advanced Development include:

- implementation of an investment project within the boundaries of Naberezhnye Chelny;

- permitted economic activities;

- creation of jobs:

• **for new businesses** - not less than 20 during the frst year of the project and 10 in subsequent years;

• **for existing businesses** - not less than the average number of employees of the legal entity for the last 3 years;

- the volume of capital investments not less than RUB 5 million in the frst year after inclusion in the register and RUB 45 million in the subsequent years

- attraction of foreign labour force in the amount not exceeding 25% of the total number of employees. 2016 Project start-up eyar

# Industrial park "Tyulyachi"

Industrial park "Tyulyachi" created in 2012 is one of the first parks located in the rural area, it is focused not by the branch principle, but by the principle of a choice of initial material from which production for various branches of economy will be created. Use of polymeric materials which possess the inexhaustible potential of opportunities for development of productions is the basis for focus.

- To place not less than 30-35 modern, hi-tech productions.
- To create not less than 350-450 workplaces in 2015, not less than 900 by 2018 that will provide reduction of outflow of active part of the population from Tyulyachinsky MR not less than for 50%.
- To promote increase in revenues of the municipal budget by 25-35%.
- To assist creation of new opportunities and incentives for development of business in Tyulyachinsky region and the neighboring areas.
- To create a basis of modern production and scientific and experimental infrastructure, as bases for the subsequent development.



# Industrial Park «Kamskiye Polyany»



Industrial Park «Kamskiye Polyany» created in 2008 is an industrial site for processing of polymers into goods for automobile, furniture, textile industries, for production of packaging materials and consumer goods.

The main goal of this project was to create a network of high-tech facilities for processing of polymers produced in the Republic of Tatarstan.

Today Industrial Park «Kamskiye Polyany» has a territory of 230 hectares, that holds all necessary infrastructure, including:

Own modular boiler house with a capacity of 60 MWt and a free heat resource of up to 10 GCal/hr;

· Energy capacity of up to 10 MWt;

· Gas supply is secured by a new gas-main of 12atm, as well as a gas distribution station that supplies gas to consumers at 3atm.;

· Water supply is secured by a collector with capacity of up to 5 th.m3/day;

· Sewage network with capacity of up to 5 th.m3/day;

· Communications (landline, cellular (Megafon, Beeline, MTS), Internet (optical fiber).

The site has a convenient logistics junction:

• it is situated on the "Nizhnkemask – Chistopol – Kazan" highway;

· 90km away from the federal M-7 "Volga" highway;

· 90km away from the high-speed "Shali – Bavly" highway (under construction), which is a part of the "Europe – Western China" transportation route;

· 50km away for the "Naberezhnye Chelny – Zainsk – Almetyevsk – Bugulma" highway;

• The nearest cities: Nizhnekamsk – 50km, Naberezhnye Chelny – 90km, Chistopol – 60km, Zainsk – 50km, Almetyevsk – 100km, Kazan – 100km, Moscow – 1000km;

· Nearest railway stations: Nizhnekamsk – 50km, Zainsk – 50km, Krugloe Pole – 75km;

· Begishevo airport is situated 70km away from the site.



The territory of the KAZAN EXPO will be divided into three parts: three huge exhibition pavilions, territory for placement of temporary pavilions and a hotel. The complex also provides press centers, administrative offices, VIP / business area, workshops, commercial premises, catering areas, medical facilities, and parking for 698 cars.

In all the 60 years of existence of the WorldSkills International, the international skills competition has never been held in the largest country of the world yet. Worldskills Competition in Kazan represents a new pinnacle and new huge prospects, an opportunity to attract new global partners and enter new markets, implementation of the WSI brand promotion projects.

Kazan has rich experience in hosting extensive events with large numbers of participants. By 2019, the capital of the Republic of Tatarstan will be hosting over 20 international sports events, over 40 national and international non-sports events, including summits, conferences, festivals and competitions. The massive tangible and intangible legacy and experience and the presence of necessary infrastructure and resources, provide Kazan with the opportunity to apply for and to organise the most ambitious projects.



# **Transport infrastructure**

Transportation is one of the key branches of economy, the most important component of industrial and social infrastructure in the Republic of Tatarstan. The system of transport communications is a condition of territorial integrity of the region, unity of its economic space. It connects the Republic of Tatarstan with other regions of Russia, with the world community, being a basis of ensuring integration of the region into the global economic system.

The Republic of Tatarstan locates at the intersection of the main transport ways:

- highways and railway lines going from the East to the West, connecting the Siberian regions, Ural, Eastern Europe and the West of Russia;
- highways, the railroads and the river arteries going from the South to the North connecting the Black Sea regions, the extended territory of the Volga region, Moscow and Leningrad areas.

The Republic of Tatarstan has a developed transport network. Its basis is made by highways, the railroads, four navigable rivers: the Volga, the Kama, the Vyatka, the Belaya, oil and gas pipelines, and airlines.

Public highways of republican and federal value passing across the territory of the republic extent for 14.6 thousand km, 1066 of which are federal ones (including M7 "the Volga", M5 "Ural", "Kazan-Ulyanovsk", "Kazan-Orenburg").

The major railroads are passing through the cities of Zelenodolsk, Kazan, Agryz (part of the Moscow – Yekaterinburg road) and through oil-extracting regions of southeast part of the republic (part of the Moscow – Chelyabinsk road). The largest transport knots are the cities of Kazan, Agryz, Zelenodolsk, Bugulma, Naberezhnye Chelny.

The transcontinental corridor "Western Europe – the Western China" passes through Kazan. In Tatarstan there are 3 cargo ports, 4 passenger ports (Kazan, Naberezhnye Chelny, Chistopol, Nizhnekamsk), 6 river stations. The Kazan river port is connected by Uniform deep-water system of the European part of Russia with the Baltic, the White, the Caspian, the Azov, and the Black seas.

Tatarstan is the center of pipeline transport, largest in Eastern Europe. The main oil and gas pipelines radially disperse from Almetyevsk and Bugulma industrial hub to the northeast (Perm), the East (Ufa), the Southeast (Orenburg), the Southwest (Samara) and the West (Kazan). The Almetyevsk city is a starting point of the "Druzhba" oil pipeline which transports Tatarstan oil to the European countries.



The large cities of the republic are connected by regular airlines with 37 cities of Russia and CIS, and also with foreign countries. In the territory of the republic there are 2 international airports **"Kazan"** and **"Begishevo"** 



# Sviyazhsk interregional multi-modal logistics terminal

Located at the intersection of international transport corridors "North-South" and "West-East" with access to Federal highways, Sviyazhsk interregional multi-modal logistics terminal in the long term, is capable to become the core transport and logistics system of cargo transportation in The Volga region, that is a central part of Russia. The terminal will become a major transit point of export and import cargo to all regions of the Volga region as well as the key river port for transportation of goods by international transport corridors. In addition, cargo transport organization in international transport corridors can satisfy the basic requirements of internal and external customers of transport services to minimize the cost of resources all the way long of delivery by a principle "door to door". This is the place where railways, Russian federal highway, river port meet.

## Western Europe – Western China

Major positive line of this Project compared with existing alternative corridors (such as highway TransSib, and sea through Suez Channel) is its length and time on the way. If going by sea Corridor, takes 45 days, and by TranSib – 14 days, but the way through Corridor "Western Europe – Western China" from Lianyungang port through the European boarder it will take 10 days only. The Project will provide cargo transportation on three main directions: China – Kazakhstan, China – Central Asia, China – Kazakhstan – Russia – Western Europe.

Wide application of new construction materials including concrete coverage which considerably increases the strength and longevity of highways has already started.

Total length of the Corridor Saint-Petersburg – Moscow – Nizhniy Novgorod – Kazan – Orenburg – Aktobe – Kyzyl-Orda – Shymkent – Taraz – Kordai – Almaty – Khorgos – Urumqi – Lanzhou – Changzhou – Lianyungang is 8,445 km.

# Registration of foreign business in Russia

Nowadays, 3 general variants of foreign business organization are practiced in the Russian Federation:

- · an affiliated company;
- · a representative office;
- a branch office

#### Variant 1: an Affiliated company

Limited Liability Company (LLC)

LLC is the most widespread form of the legal entity with the smallest number of the obligatory requirements burdening owners of the company. The capital of LLC shares in "parts" (shares) which don't act as "stock certificates" and therefore are not under requirements of the Russian legislation of securities and aren't a subject of registration as securities in the appropriate Russian government bodies. Share of participation of each owner of the company is defined depending on the size of a contribution to the capital.

#### Joint-Stock Company (JSC)

The joint-stock company is seldom used for creation of the new enterprises in Russia in view of more complicated legislative requirements therefore only the main data on this type of the companies is reported further:

• The joint-stock company exists in two main forms open joint stock company (the number of participants isn't limited) and closed joint stock company (number of participants is not more than 50);

• The capital of the joint-stock company shares into stock certificates which fall under requirements of the Russian legislation on securities and are subject of registration as securities in the appropriate Russian government bodies. Data recording of the companies is carried out in ta authorities.

#### Variant 2: a Representative office

The foreign company can do business in Russia using representative office.

Representative office of the foreign company isn't an independent legal entity, represents interests of the foreign company in Russia. The head of the representative office is appointed by the foreign company and acts on the basis of a power of attorney. Representative offices are registered in the State Registration Chamber of the Ministry of Justice of the Russian Federation and/or the Russian Chamber of Commerce and Industry ( the choice influences accreditation conditions).

Except accreditation, process of registration of a representative office includes registration in taxauthorities, bodies of statistics and the state offbudget funds, and also opening of bank accounts.

#### Variant 3: a Branch

The foreign company can do business in Russia using a branch. The branch of the foreign company isn't an independent legal entity. The branch of the foreign company is a division of this firm which fulfills all or a part of its functions. The branch has the right to conduct independent commercial activity.

Branches have to be accredited in the State Registration Chamber of the Ministry of Justice of the Russian Federation.

Except accreditation, process of registration of branch includes registration in tax authorities, bodies of statistics and the state off-budget funds, and also opening of bank accounts.

# **Migration policy**

Foreign citizens and stateless persons are obliged to show the valid documents proving their identity recognized by the Russian Federation in its quality and the visa at the entry into the Russian Federation and departure from the Russian Federation. An identification paper of the foreign citizen is the passport of the foreign citizen or another document recognized as the document according to the international treaty of the Russian Federation.

Entering the territory of the Russian Federation without visa is allowed for Citizens of the states, which signed the international contracts with the Russian Federation on mutual trips providing entrance, departure, movement, transit and stay in the Russian Federation without visas. (Agreements on mutual visa-free trips have been concluded with and the Azerbaijan Republic, the Republic of Armenia, the Republic of Belarus, the Republic of Moldova, the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, the Republic of Uzbekistan).

#### Citizenship of the Russian Federation can be acquired:

- at birth;
- as a result of citizenship reception of the Russian Federation in the general order;
- as a result of citizenship reception of the Russian Federation in the simplified order;
- as a result of citizenship restoration of the Russian Federation;
- and also on other bases provided by this Federal law or international treaties of the Russian Federation.

The general and simplified orders differ in the bases, conditions, terms of consideration of materials (the general order takes 1 year, and the simplified order takes up to 6 months from the date of submission of all necessary and properly processed documents) and competence of decision-making. Using the general order the decision is made by the President of the Russian Federation, using the simplified order the decision is made by the President of FMS of Russia in regions of the Russian Federation. There are no quotas of acquisition of the Russian citizenship. The privilege of acquisition of citizenship of the Russian Federation on the basis of social, racial, national, language or religious identity isn't established.
