

The opening of the new service metal centre "MMK-Coskunoz-Alabuga"

On May 14, the opening ceremony of the first in the Volga region service metal centre "MMK-Coskunoz-Alabuga" was held with the participation of Tatarstan's President Rustam Minnikhanov at SEZ "Alabuga". Chairman of the Board of Directors of the MMK Viktor Rashnikov, Deputy Minister of Industry and Trade of the Russian Federation Aleksandr Morozov, Governor of Chelyabinsk Region Boris Dubrovsky, President and CEO of Ford Sollers Adil Shirinov took part in the opening ceremony.





The opening of the first Castorama store in Kazan

On April 25, the official opening of the first store of goods for home and repair Castorama, a part of Kingfisher international company, was held. Investments in the store in Kazan amounted to 2 billion rubles, 190 new jobs were created.

The ceremony was attended by the Director General of Castorama Russia Vincent Guffroy. He said that Kazan has always been an example of a constantly evolving region for the company. «You give an opportunity to develop small- and medium-sized business, that is why we decide to open a store here. Our aim is to give a customer the possibility to make a trip to a fascinating world. Now we are in the process of a total redesign to offer goods that will be sold only in our store", – the speaker reported on the opening ceremony. — "We have spent a long time with the customers to study their needs. We desire our brand to make the lives of our customers better".



The opening of the Russian-American "KAI-Keysight" Laboratory of Computer-Aided Design Systems

On March 29, "KAI-Keysight" Laboratory of Computer-Aided Design Systems (CADS) was opened on the basis of the German-Russian Institute of Advanced Technologies (GRIAT) KNRTU-KAI. It is a joint project with the company Keysight Technologies (USA).

Keysight Technologies is one of the world's leaders in production of measuring and control equipment, computer design systems used in high-tech companies around the world. The American company provides Tatarstan's University's laboratories with licenses for 52 workplaces of CADS Keysight EEsof full package, including such famous systems as SystemVue, ADS, Genesys, EMPro, IC-CAP.

The KAI-Keysight Laboratory is designed to become the base for training students in all relevant areas of bachelor's, specialist's, and master's programs, arranging retraining and advanced



training courses for experts at high-tech enterprises which are strategic partners of KNRTU-KAI, and carrying out research and development.

Schneider Electric company opened an Innovation Center in Innopolis

On June 16, in the city of high technologies Innopolis in the Republic of Tatarstan, the Innovation Center of the international company Schneider Electric, world expert in the sphere of energy management and automation, was solemnly launched. The project was launched by the President of the Republic of Tatarstan Rustam Minnikhanov and Deputy Chief Executive Officer of Schneider Electric in the world, Member of the Board, Emmanuel Babeau.

The project is an office and a laboratory for research and development work on adaptation, development and implementation of advanced solutions of Schneider Electric in the sphere of software, automation and information security systems for industrial use. At the first stage, 10 highly qualified engineers will work in the Center of Innovations with the opportunity to expand the number of jobs in future. The investment in the project is tentatively estimated at the minimum of 1 million Euro over the first 5 years.



In Tatarstan, the construction of new Haier plant started

On May 29, the ceremony of laying the cornerstone of the foundation of Haier washing machine plant took place in Naberezhnye Chelny. The plant will become the first stage of construction of industrial park of Chinese company in Naberezhnye Chelny.

Haier Vice-President Shu Hai, Minister of Economy of Tatarstan Farid Abdulganiev, Chinese Consul General to Kazan Wu Yingqin, Major of Naberezhnye Chelny Nail Magdeev took part in the ceremony. It is planned that the production of Haier washing machines will be launched in Tatarstan in 2019. Television production will be opened the second. At the third stage the manufacturing of complex household appliances is planned.

The amount of investment in the project is 1 billion dollars. It is a large project; it will contain 12 plants.



The opening of the joint scientific and research center of Ericsson and MTS

On April 25, the official opening ceremony of the Scientific and Research Center took place. Innovative products and solutions based on Ericsson's and MTS's 5G and Internet of things (IoT) technologies will be developed there and distributed to the Russian and global markets. The agreement on establishment of such center in Tatarstan was signed on February 28 in Barcelona at the World Mobile Congress between Ericsson and MTS companies and Tatarstan Investment Development Agency.

At the first stage, the Center in Innopolis will focus on developing solutions for "Smart city" for the needs of Russian cities. The work of the Center will involve the staff of the company: developers, engineers, business analysts and specialists in business development. MTS will provide the Center with space, data center facilities, network infrastructure to conduct examinations, skills and resources of the existing Center of Innovations and recently established by IoT-lab, while Ericsson will supply cloud and telecom technologies (Ericsson IoT Accelerator, Massive IoT








